Dear West St. Paul Residents and Stakeholders:

We would like to provide you with an update on the status of the Wastewater Sewer Project for the Rural Municipality of West St. Paul.

What has happened since our November Bulletin?

The Council of the Rural Municipality has been working hard to provide the necessary legislation and policies that will ensure the Wastewater Sewer Project continues to move forward in a timely and cost-effective manner.

By-Law 2013-17 to authorize the expenditure and borrowing of money for the Riverdale LID

Following the Public Hearing held October 21, 2013, a Special Meeting was held to give First Reading to By-Law 2013-17, which authorizes the expenditure and borrowing of money for the Local Improvement District. By-Law 2013-17 is now awaiting approval from the Municipal Board. Once this By-Law receives approval from the Municipal Board, Council will be able to give final readings to the By-Law.

- Phase 1 is currently planned to be constructed in two (2) separate construction contracts.
- The scope and timing of these contracts will be developed as the detailed design proceeds.
- The proposed construction completion date is September 2015.

Sewer Utility Replacement Reserve Fund By-Law

The Sewer Utility Replacement Reserve Fund By-Law 2013-12 received third and final reading at the December 12, 2013 meeting of Council. This Reserve has been created for the purpose of funding capital expenditures for municipal infrastructure and service requirements.

This By-Law will help to ensure that a sufficient sewer levy is obtained from new developments within the Municipality to contribute to the anticipated necessary development, repairs, expansion, replacement and renewal of the sewer infrastructure of the Municipality.

Sewer Levies will be collected on new development within the Municipality as follows:

Class of Development	Fees
Residential	\$2,500/lot
Multi-family Residential	\$2,500/dwelling unit

*THESE LEVIES ARE APPLICABLE TO NEW LOTS ONLY

Lot Frontage Calculation Policy

The purpose of this policy is to establish procedures for the measurement of frontages including corner and irregular shaped lots for the purpose of calculating charges owing for the connection into the municipal sewer/and or water system within the Municipality.

The Policy will be going to council on February 20, 2014 for approval.
